



## CONTEST "Win a monthly subscription to Cupra Formentor 1.5 !" RULES OF ORGANIZATION

1 November 2024 – 30 of November 2024  
Riga

### 1. Organiser

**1.1.** "MyBee Latvia", SIA, company code 4020343113, address Riga, Zemitāna street 9 k-1, LV-1012 (hereinafter referred to as the Organiser) organises the Competition "**Win a Cupra Formentor 1.5 subscription for a month!**" (hereinafter referred to as the "Contest"), which is conducted in accordance with the following rules (hereinafter referred to as the "Rules").

**1. 2.** The place of the Contest is Shopping mall "Domina", Ieriķu street 3, Suburb of Vidzeme, Riga, LV-1084, Latvia.

### 2. Period of the Contest organization

**2.1** The Competition shall be organised and held from 1 November 2024 to 30 November 2024.

### 3. Contest participants

**3.1** A person who scans a QR code and subscribes to MyBee's newsletters (marketing offers) is deemed to be an entrant. No purchase of any goods or services is required to enter ("Contestant").

### 4. Terms and conditions of participation in the Contest

**4.1** In order to participate in the Competition and win a prize, the Contestant must subscribe to MyBee newsletters (marketing offers) by scanning a QR code between 1 November 2024 and 30 November 2024.

### 5. Determination of Winners and Prizes

**5.1** By participating in the Competition, Entrants are eligible to win a monthly subscription to a Cupra Formentor 1.5 car (the "Prize").

**5.2** The subscription includes car insurance, roadside assistance, vehicle delivery services and a car wash subscription. Any additional costs associated with the use of the Prize that are not specified in these Terms and Conditions, such as fuel or parking costs, are not reimbursable.

**5.3** During the Competition, Entrants will be provided with a total of one car subscription service per month. Only one Prize can be won per Contestant.

**5.4** The winner of the Competition will be determined by the Organiser's responsible employee using software. Prize winners will be drawn by lot by 6 December 2024. The Prize may be claimed until 13 December 2024. After this date, the prize will no longer be awarded.

**5.5** Prizes are not redeemable for cash, Organiser's gifts or discount vouchers. Unclaimed Prizes will not be refunded in any form.

### 6. Informing the Winners and collecting the Prizes

**6.1** The winning Contestant will be contacted by 6 December 2024 at the email address and telephone number provided by the winning Contestant regarding the Prize.

**6.2** If the winning Contestant fails to reply to the email or call within 7 (seven) calendar days from the date of the email and call informing them that they have won the Prize, or fails to collect the Prize, then their win will be forfeited and the Contestant will not be entitled to claim the Prize or to any damages whatsoever, including any damages in connection with the loss of their Prize and/or their participation in the Contest. In such event, no redrawing will take place.

**6.3** The Prize will be delivered at a prearranged time and place. You will be required to present your identity document and driving licence (no copies will be made) when collecting your prize to identify and confirm that you are the winner of the Competition and to sign a car rental agreement (for a period of 1 month), which will include your name, surname, personal identification number, address, driving licence number and expiry date, details of your prize such as the make of the car, its registration number, mileage etc.

## **7. Dispute procedures**

**7.1** All complaints relating to the Competition, including complaints relating to the selection of winners and/or the Prize award procedure, shall be dealt with by the Organiser.

**7.2** Complaints must be submitted to the Organiser by email to [info@mybee.lv](mailto:info@mybee.lv) no later than 15 (fifteen) working days from the date of announcement of the winner.

**7.3** The Organiser must investigate the complaint no later than 15 (fifteen) days from the date of receipt.

## **8. Protection of personal data**

**8.1** The Organiser is the controller of the personal data of the Contestants.

**8.2.** The persons participating in the Contest agree that the provided email address will be used in further marketing campaigns of the Organiser for 24 months from the date of consent or until the date of withdrawal of marketing (hereinafter referred to as "Marketing"). Subscription to the Organiser's Marketing is an essential condition of participation in the Competition.

**8.3** The persons participating in the Contest agree to the Organiser's processing of the data (name, surname, email address, telephone number) provided by them during the Contest for the purposes of organising the Contest, awarding the Prize and providing information.

**8.4** The basis for the processing of these data is the consent of the Contestants. Contestants have the right to object to the processing of their personal data or to withdraw their consent at any time. Upon receipt of such a request from a Contestant to cease the processing of his/her personal data during the period of the Contest, the Contestant shall no longer participate in the Contest and shall not be eligible for the Prize.

**8.5** When processing personal data, the Data Controller shall implement specific organisational and technical security measures to protect against disclosure of the data and against any other unlawful processing. All personal data relating to the organisation and administration of the Competition, the identification and announcement of the winners will be retained for the duration of the Competition and for a period of 12 months following the end of the Competition, or until the Contestant withdraws his/her consent to the processing of his/her personal data.

**8.6** Contestants have the right to request access to their personal data processed.

**8.7** Contestants have the right to request the rectification of inaccurate personal data relating to them.

**8.8.** Contestants have the right to request the erasure of personal data concerning them.

**8.9** Contestants have the right to restrict the processing of their data.

## **9. Responsibility**

**9.1** The Organiser shall not be liable for any loss incurred by a Contestant as a result of the termination of the Contest or the rescheduling of the Contest. The Organiser shall also not be liable for, and shall not indemnify the Contestant against, any loss resulting from a change in the procedure for claiming Prizes.

**9.2** The Organiser does not assume any obligations in relation to the quality of the Prizes and does not guarantee the quality of the Prizes.

## **10. Taxes and other costs**

**10.1** Taxes in connection with this Competition shall be payable by the Promoter, subject to any tax liability imposed by law.

## **11. Other Terms and Conditions**

**11.1** Persons taking the steps set out in these Terms and Conditions to enter the Competition confirm their agreement to enter the Competition.

**11.2** Persons participating in the Competition confirm that they unconditionally accept and agree to be bound by these Rules.
